

2025 Toronto International Boat Show

Buy A BOAT and ENTER TO WIN \$10,000

These rules govern the Contest at the 2025 Toronto International Boat Show.

The Canadian Boat Shows (CBS), The Toronto International Boat Show, respect your privacy. Personal information provided to us on this ballot is solely for use by the Canadian Boat Shows as producers of the Toronto International Boat Show (TIBS). The information will not be sold or traded either now or in the future to any company, association, or group.

Limit of one (1) entry per person. No purchase necessary. Open to residents of Ontario, 18 years of age or older, who hold a valid Ontario Class G Drivers' License, and have had no criminal convictions arising out of the use or operation of a motor vehicle. Employee, contractors, suppliers, and exhibitors of the TIBS and their immediate families, and anyone living with any employee, of the Contest Sponsors or its or their corporate affiliates, advertising or promotional agencies or affiliates, is ineligible to enter and win.

The contest period is January 18, 2025 – 10:00 am to January 26, 2025 – 8:00 pm. Official entry is at Salon 103, Galleria Lobby – Hall A, Toronto International Boat Show at the show office counter, within boat dealers' individual spaces and at the information booths. The Toronto International Boat Show is located at Enercare Centre, Exhibition Place, 100 Princes' Blvd, Toronto, Ontario, Canada. Odds of winning depend on the total number of entries received. The potential winner must correctly answer a mathematical skill-testing question.

The Contest sponsor is the Toronto International Boat Show, Canadian Boat Shows and Royal Bank of Canada.

On January 26, 2025, and after the 2025 Toronto International Boat Show closes, a random draw will take place from all eligible entries received on or before the Contest Deadline of Sunday, January 26, 2025, at 8:00 pm EST. The first eligible entry drawn will be eligible to win the \$10,000. The Contest Sponsor will contact the potential winner after the draw, by telephone at the daytime number recorded on their entry, during regular business hours (EST). The potential winner will have 7 days to respond to this telephone call. If the potential winner is disqualified from eligibility, does not correctly answer the mathematical skill-testing question, or cannot be contacted within the 7-day period, the Contest Sponsor shall have the right to redraw for another potential winner, and the Contest Sponsor shall be fully and completely released and discharged from any liability or responsibility in the regard. Contest Sponsor may redraw until such time as a potential winner satisfies the terms of this section.

The winner has until June 30, 2025, to take possession of the boat from the dealer. The potential winner or dealer on behalf of the potential winner must produce a valid copy of the proof of purchase invoice. Should the invoice prove to be invalid then the potential winner becomes ineligible to collect the prize.

The cheque will be provided and presented when the eligible winner takes possession of the boat.

By entering this Contest, entrants' consent to the collection, use and disclosure of their personal information contained in their official entry form for the purposes of running this Contest. We will use personal contact information to administer the Contest, including

contacting, announcing, and promoting the prize winner. Winner information will be disclosed to the prize provider for fulfillment.

The sponsor may, in their sole discretion, prohibit any person from entering any contest whom they believe to be abusing the Contest Rules. Such abuse includes entering false information and entering more than once per person.

This contest is governed by and subject to all applicable federal, provincial, and municipal laws and regulations and is void where prohibited.
