Authorization Request – Sample Food and/or Beverage Distribution

Oakview Group Hospitality has the exclusive food and beverage distribution rights withinthe Direct organizations and/or exhibitors may distribute **SAMPLE** food and/or beverage products **ONLY** upon written authorization and adherence to **ALL** of the conditions outlined below.

- a) Food samples must be limited to 'bite size' 2x2 inches / 5x5 cm or 2oz / 59 gram
- b) Non-alcoholic beverage samples must be approved by Oakview Group and limited to 4oz / 118ml.
- c) Food or beverage items for sale must be pre-packaged in such quantities as to be solely intended for home consumption. Each individual package must be equal to or greater than one kilogram by weight or one litre by volume unless otherwise approved by Oakview Group
- d) Any items sold or sampled for intended consumption on the show floor must be approved in writing by Oakview Group Hospitality and may be subject to a buyout fee at the discretion of Oakview Group
- e) Exhibitors participating in the Food/ Beverage program must adhere to policies and recommendations set forth by the City of Toronto Department of Public Health
- f) A Certificate of Insurance Form must be completed or a copy of your Certificate submitted
- g) For alcoholic beverage sampling, please refer to requirement #6 on the subsequent page of this form

SAMPLING AND FOOD OPERATION REQUIREMENTS

Oakview Group Hospitality at the Enercare Centre reserve the right to control the sale and/or sampling of food or beverages, including confectioneries. *Food samples must not exceed 59 grams (2oz) or 118 millilitres (4oz) by volume* and food and beverage items for sale must be pre-packaged in such quantities as to be solely intended for home consumption and equal to no less than one kilogram by weight or one litre by volume

If food and/or beverage products are sold for immediate consumption within Enercare Centre, the exhibitor in question will be asked to stop selling these food and/or beverage products. Should the practice continue, the exhibitor **MUST** comply with Enercare Centre Subcontractor's Agreement

Enercare Centre also reserves the right to ensure that samples of food and/or beverage are given out and done so in a safe and orderly manner. Should Enercare Centre deem a sampling program as unsafe for public or private consumption, the sampling program in question will cease to operate

The following outlines the food operation and sampling requirements at Exhibition Place:

- 1. Any exhibitor wishing to give sample food and/or beverage at the Enercare Centre must complete the Authorization Request Sample Food and/or Beverage Distribution form by the date specified on the application.
- 2. Must have hand sanitize pump at your booth, wear gloves
- 3. Must have seating available for the customer to consume the item
- 4. Only those exhibitors who have the approval of Oakview Group will be allowed to participate in a sampling program.
- 5. All exhibitors participating in a sampling program must provide the standard liability insurance and must name Oakview Group Food Services and the Board of Governors' of Exhibition Place as additional named insured. Exhibitors who fail to provide the proper Certificate of Insurance will NOT be allowed to give out samples at Enercare Centre. See attached form
- 6. All exhibitors participating in a sampling program must adhere to The Board of Governors' of Exhibition Place temporary food establishment and operational requirements. (see attached)
- 7. All exhibitors who are giving out samples must adhere to the City of Toronto, Department of Public Health Recommendations for Food Operators. These include, but

are not limited to, a separate and proper hand and utensil washing facility as outlined in the recommendations. Failure to comply will result in the sampling program ceasing until compliance with these regulations are adhered

- 8. Exhibitors wishing to give out samples of beer, wine or other alcoholic beverages must comply with the Alcohol and Gaming Commission of Ontario regulations concerning sampling. The Exhibitor must be the *manufacturer*, *processor and/or distributor* of the product and must be related to the purpose of the show in order to be authorized for sampling. Any exhibitors sampling alcohol must remit to Oakview Group a negotiated buy-out fee.
 - a. Samples must be 2oz / 59ml or less and served in disposable cups. No cans or bottles will be permitted
 - b. Vendors MUST submit proof of having Liability Insurance for exhibiting and must name Oakview Group Food Services and the Board of Governors of Exhibition Place as an additional named insured
 - c. Alcohol can only be dispensed by a Smart Serve Certified personnel (Oakview Group will require proof of certification)
- 9. Cooking Demonstrations Operation of gas cooking appliances, barbeques or deep fat fryers is not allowed for cooking demonstrations. No cooking appliance is to be placed on combustible furnishings or too close to any combustible materials. Cooking areas must have one dry chemical fire extinguisher bearing the Underwriter's Laboratories of Canada designation 10-BC provided by the Show Manager of the exhibitor. Any variance to this policy must be approved in writing by Enercare Centre management.

To ensure that food sampling is done in a safe manner, Enercare Centre reiterates to exhibitors giving out samples of food and/or beverages that they must adhere to policies and recommendations put forth by the City of Toronto Department of Public Health.
