

## Skipperi and 2024 Toronto International Boat Show Giveaway “Your Ticket to Unlimited Boating in 2024” Official Enter to Win Rules

1. **Agreement:** These rules govern Skipperi Inc. & Toronto International Boat Show, Enter to Win a Giveaway of one Weekdays + Weekends Subscription Membership for unlimited use of Skipperi Fleet at any Skipperi harbour location in the period from May 1 to October 31, 2024. No purchase is necessary to enter the Contest. The act of entering the Contest constitutes acceptance of the Contest rules and the decisions of the Contest judges, which decisions shall be final and binding upon all entrants.
2. **Sponsor:** The Contest sponsor and prize participant (“Sponsor”) is Skipperi Inc. and promo collaborator is Canadian Boat Shows Inc., owner of the Toronto International Boat Show.
3. **Eligibility:** To enter and to be eligible to win, an individual must be a legal resident of Ontario (must reside within reasonable distance to Skipperi locations to utilize the membership prize) and must have reached the age of 21. No boating experience is necessary. One entry per person. Employees and their immediate family members (parents, siblings, children, spouse), and persons domiciled with an employee of the Contest Sponsor, Contest Promo Collaborator its marketing agencies, and judges, are ineligible.
4. **Contest:** To enter contest, access the Contest web page at <https://www.skipperi.ca/torontoboatshow>. Also, enter to win on site at 2024 Toronto International Boat Show at booth #137 beginning at 1pm EST, Friday, January 19, 2024, and ends at 5 PM EST Sunday, January 28, 2024. Online and Onsite contest is managed by Skipperi Inc. Ballots available at the show. The potential winner will be chosen by random draw and announced on Monday, January 29, 2024. The potential winner will be contacted by telephone or email by a representative of the Sponsor and must reply within 48 hours to maintain eligibility. If the potential winner cannot be contacted within this time period or fails to respond to any attempted contact, such potential winner will be disqualified, his or her entry will be declared null and void and the Sponsor reserves the right, in its sole and absolute discretion, to select at random another eligible entry, in which event these provisions shall apply to such other eligible entry. To be eligible to win, the potential winner must correctly answer a mathematical skill-testing question, without assistance or mechanical or electronic aid.
5. **Prize:** One (1) Membership subscription: Weekdays + Weekend with 7 days a week access to new, fully equipped Skipperi fleet of 17’-21’ Starcraft SVX boats at any of the 8 harbors across Toronto and the GTA.. Value at approx. \$5,694 (excluding taxes). Prize includes: Boat Insurance (maximum deductible is \$2000), complimentary practical training and PCOC test (in case the winner does not already possess Pleasure Craft Operator Card), Complimentary virtual boating course, Mooring Fees, Maintenance, Storage. The winner will be responsible to pay for their own fuel consumption during the 2024 season boating sessions, and must enter a valid payment method on file for their Skipperi subscription to cover the fuel costs and any extras not listed as a part of this prize. Winner accepting the prize is required to uphold Skipperi Fleet membership contract with \$0 monthly fee for 2024 (the full text can be found online at <https://www.skipperi.ca/terms/contract-fleet-2023a> and), comply with General terms of service and privacy policy ( full text can be found on <https://www.skipperi.ca/legal>) and follow Skipperi contract rules and expected member conduct, when operating Skipperi fleet vessels. Prize must be redeemed during time stated in these rules and will not be rescheduled or

substituted. If the winner is unable or unwilling to accept or otherwise redeem the prize on the terms it is awarded, the prize shall be forfeited, and no cash or substitutes will be provided in whole or in part.

Such Release must be returned via fax/email within ten (10) business days of the date on the covering letter and/or email accompanying the Release. If the Release is not returned within ten (10) business days of the date on the covering letter and/or email accompanying the Release, the Contest prize will be forfeited.
